No Retaliation

Rimini Street prohibits retaliation against any individual who, in good faith, reports a suspected violation of the *Rimini Street Code of Business Conduct and Ethics*, other Rimini Street policies, or applicable laws and regulations. Any instance of retaliation against an employee for reporting a concern in good faith is itself a serious violation of our Code and should be reported. Any employee found to have engaged in such retaliation may be subject to disciplinary action, up to and including termination of employment.
